MINUTES OF REGUALR MEETING THE BOARD REGIONAL UNIVERSITY SYSTEM OF OKLAHOMA BOARD OF REGENTS OCTOBER 2, 2025

A regular meeting of the Board of Regents governing East Central University, Southeastern Oklahoma State University, Southwestern Oklahoma State University, Northeastern State University, Northwestern Oklahoma State University and the University of Central Oklahoma was called to order at Southeastern Oklahoma State University Durant, Halley McKinney Building Room A, at 1:00 p.m., on October 2, 2025.

The following Regents were present for all or parts of the meeting: Jane McDermott, Chair of the Board, presiding; Regents Susan Winchester, Amy Anne Ford, Lake Carpenter, Chuck Perry, and Thomas Kupiec. Connie Reilly and Ryan Walters were absent.

Aviation Sciences Institute Renovations

 Project Description: Request approval to award the renovation of Aviation Sciences Institute at Eaker Field to Mid-Plains Construction. In addition, request approval to include the three alternates which were part of the original construction documents.

The renovation includes modernizing office and classroom spaces, improvements to the hangar space to allow for maintenance and training, and the creation of makerspace located within the hanger. The renovation will result in a twin, single-story modern building which will offer collaborative work and training spaces conducive to innovative, aerospace-related economic activities.

This project also includes three alternates that were part of the original construction design. These alternates are in the hangar area and include 1) updated LED lighting, 2) high velocity low speed fans, and 3) pusher motors for the large hangar doors.
