A. FACILITIES STEWARDSHIP COMMITTEE –Regent Lake Carpenter (Attachment B, Pages 45-51)

Report of the Facilities Stewardship Committee, Thursday, November 11, 2021, 3:00 p.m., Northeastern State University, Webb Tower, 6<sup>th</sup> Floor, Tahlequah, Oklahoma.

Regent Carpenter reported that the Committee members, Presidents, and Business Officers discussed each of the requests. Regent Carpenter reported that the Southeastern Oklahoma State University winter weather repairs will be almost completely funded by Risk Management Funds minus the \$100,000 deductible. The damages were caused by the big snow and ice storm last February.

Regent Carpenter expressed enthusiasm regarding NSU's proposed new College of Optometry Building. The site of the new facility is on Crafton Street. The new facility will allow NSU to enroll 40 students instead of the current 28 students. It will modernize the facilities and allow NSU to not only provide optometry services in the Northeastern part of the state, but also provide optometrists throughout the state workforce and throughout the region. The NSU Optometry Program is first-rate and nationally ranked and the Regents are proud of it and look forward to securing funding for the building.

Regent Carpenter also reported that UCO will be renaming its football stadium "Chad Richison Stadium" as part of a naming rights agreement with alumnus and Paycom CEO Chad Richison. Mr. Richison has been a long-time large donor to UCO and its athletics programs. The Regents extend their appreciation to Mr. Richison for his support.

Regent Carpenter noted that Yukon Public Schools passed a \$200 million bond issue on November 9, 2021. SWOSU and Yukon will be partnering to provide higher education on site at a Yukon center to be constructed which will create 10 classrooms and office space designated for SWOSU. Canadian County is the fastest growing county in the state. Regent Carpenter also noted that RUSO General Counsel, Debra Lyon, will have recommendations for the agreement and approval of this agreement will be contingent upon the approval of the General Counsel.

# C. SYSTEM ADVANCEMENT COMMITTEE–Chair, Regent Susan Winchester

### Report of the System Advancement Committee, Thursday, November 11, 2021, 4:00 p.m., Northeastern State University, Webb Tower, 6<sup>th</sup> Floor, Tahlequah, Oklahoma.

1. Discussion and possible action regarding Oklahoma State Regents for Higher Education Legislative Agenda.

Regent Winchester reported that the new Chancellor, Allison Garrett, was at NSU Thursday for the Veteran's Monument Dedication. The Board is looking forward to working with Chancellor Garrett. Regent Winchester reported that the State Regents' Legislative Agenda budget request was submitted to the Legislature on November 4, 2021 when it was RUSO universities filed budget needs publicly announced. surveys with the State Regents on October 1, 2021 which stated their priorities for additional funding beyond mandatory cost increases and regular operations. However, they have had very little input into the Legislative Agenda, which does not reflect the priority funding needs of RUSO universities. For example, the state regents have announced that they will advocate for additional funding of \$12.9 million for much needed engineering programs, but that funding is intended to be allocated; \$5 million dollars each to OU and OSU; \$500,000 to UCO, and \$100,000 to every other institution in the state. The Committee is not clear on how this request for allocating the \$12.9 million was developed. We know from meeting with Kristian Olivero, the technical director at Tinker, that Oklahoma higher education needs to provide 3000 engineers to the Oklahoma workforce every year. The state is currently graduating 1553 engineers and half of them are leaving the state. RUSO graduates stay in the state at a rate of 92% their first year after graduation. OU in particular is turning away many students that want to enroll in engineering because the programs are expensive to provide and they have publicly referred to them as "loss leaders." RUSO institutions want to be able to offer engineering programs. Both ECU and NSU have filed letters of intent to offer mechanical engineering programs with the state regents and OSU has already indicated that it will protest.

There needs to be a way to get the funding that will allow RUSO to provide the programs that meet our state's critical degreed workforce needs.

2. Discussion and possible action regarding Higher Education Day 2022.

Higher Education Day has not been set yet. It is primarily an opportunity for students to interact with legislators and have a hands on learning experience about how the legislature works. The Committee always looks forward to Higher Education Day and will continue to do their part to support it.

3. Discussion and possible action regarding FY 2022 RUSO legislative advocacy agenda plan.

The Committee proposes having a meeting with the new chancellor as soon as possible to discuss these issues and address the funding disparities in the current funding model. The Committee is optimistic that she will be willing to listen and work with them to create a process that is directed to meeting the state's present and future degreed workforce needs and understands the significant role that RUSO plays in creating the degreed workforce that stays in Oklahoma.

4. Update on RUSO Fall Newsletter.

Regent Winchester reported the RUSO Fall Newsletter was sent to all employees on October 24, 2021. The industry standard in education for the open rate of newsletters is 24%. The RUSO open rate is consistently in the 40% range. This time it was 42.8%. The op ed from Regent Reilly was the most clicked on piece. It emphasized that RUSO universities on average cost 46% less to attend than OU and OSU because of hidden academic service fees they charge that are often difficult to determine prior to enrollment.

Regent Winchester reminded everyone to please share the RUSO newsletter with legislators and to make themselves available as a resource for them to understand the RUSO system and what RUSO has to offer.

Regent Ford reported that the Committee is continuing to work on the proposed conflict of interest policy and plan to have a recommendation for the Board in January 2022.

### VI. INFORMATIONAL PRESENTATION — LEGISLATIVE BUDGET PROCESS — SENATOR ROGER THOMPSON, SENATE APPROPRIATIONS COMMITTEE CHAIR

Senator Thompson provided valuable insight to the legislative budgeting process. He discussed the following:

- The budget process begins with the State Board of Equalization's certification of revenue available for the Legislature to spend for the coming fiscal year. The Board of Equalization meets in December for this purpose. The Governor prepares his budget from this estimate. The Board also meets in February and June to certify revenue estimates for the upcoming budget year. Estimates are prepared by the Oklahoma Tax Commission and other agencies. The Legislature uses the February estimates for appropriations legislation.
- Senator Thompson has been working with national economic rating institutions that depict the full economic picture of Oklahoma and the health and wealth of the state for budget preparation and process.
- Agencies submitted their budget requests for consideration by the legislature. These reports will be reviewed by the fiscal analysts at the state capitol on both the house and senate side for consideration in the FY 2023 budget.
- Senator Thompson encouraged regents to focus on critical occupations shortages and efforts to address and meet the needs of the STEM degreed workforce and the production of STEM graduates.

Chair Reilly declared a break at 10:17 a.m.

The meeting resumed at 10:30 a.m.

President Newsom reported that during the homecoming festivities, SE renamed the small playhouse, which is a room in the theatre building after Dell McClain, the long-time theater department director at SE. His posthumous giving campaign resulted in three endowed theatre scholarships.

President Cunningham reported that last month NWOSU was awarded a Title III Strengthening Institutions Grant totaling a little over \$2 million. The grant is designed to help higher education institutions expand their capacity to serve at-risk students by improving and strengthening the institution's academic quality, institutional management and fiscal stability. Northwestern will use these funds to enhance the programs, people and facilities needed to provide comprehensive career preparation for students from their first day on campus through graduation. More specifically, Northwestern's Title III Leadership, Academic Success, and Superior Outcomes (LASSO): Enhancing Student Success, Engagement, and Purpose-Driven Education grant will provide first-time-full-time and at-risk students with the resources and knowledge to increase retention and, ultimately, graduation rates. Program participants will receive personalized student coaching and advising, attend a new and improved First-Year Experience course, and receive enhanced career counseling. Career counseling will assist students to identify an educational purpose and its connection to future career paths and help them declare a major earlier in their academic career. These two factors are known to improve academic success. LASSO will also provide professional development to faculty and staff to improve student retention rates and overall student success.

President Cunningham reported that NWOSU will be holding their fall commencement ceremony on December 5, 2021, and everyone is invited to attend.

President Neuhold-Ravikumar reported that Newsweek recently issued a national ranking list of the top 150 online schools. UCO made the list. OSU is the only other institution in Oklahoma to be on that list.

#### <u>New Program</u>

**Mechanical Engineering, B.S.** Faculty propose a new Bachelor of Science in Mechanical Engineering degree. The degree utilizes existing engineering physics courses (with a prefix / CIP code change), mathematics courses, and physics courses as well as seven new laboratory and design courses. The program fulfills a critical need in northeastern Oklahoma in both the non-urban and Tulsa Metropolitan Service Area and will be offered on the Tahlequah and Broken Arrow campuses. The letter of intent was sent to OSRHE October 25, 2021.

#### **Program Modifications**

**English Education, B.A.Ed (029).** Faculty propose adjusting the core requirements, adding a new course, ENGL 4573 Social Justice Literacies, to meet National Council of Teachers of English (NCTE) requirements. Elective course requirements will be adjusted to maintain the same total credit hours for the degree.

**Health and Human Performance, B.S. (040).** This program modification adds an option in Fitness Management as well as revises the set of core courses and the two existing options in Clinical/Wellness and Recreation/Fitness. Two new courses will support the revised Clinical Health and Wellness option.

**Social Work, B.S.W. (102).** Faculty propose modifying the minimum grade requirement for core social work courses from a D to a C to strengthen student preparation and improve students' opportunities for graduate-level work.

**Homeland Security, B.S. (156).** Faculty propose revising the program name to Homeland Security & Emergency Management to better reflect the curriculum which includes a substantial number of emergency management courses.






## Relationship to Other Funds
