SWOSU requests approval to transfer all land and buildings located at the Sayre Campus, Sayre, Oklahoma, to the Sayre Public School (SPS).

In 1993, the Board of Regents for Oklahoma Colleges for Southwestern Oklahoma State University purchased this property from Sayre Independent School District for \$630,000. Since that time, the campus has been used as an additional location for SWOSU to provide instruction for students to earn Associates degrees. At the time of purchase the following land and buildings were acquired:

#### RE: Request for Change in Academic Nomenclature

Dear Ms. McCaffree,

In accordance with OSRHE policy 3.8.2 C, the University of Central Oklahoma (UCO) requests approval of the following nomenclature change with an effective date of Fall 2022.

#### Department of Engineering and Physics to School of Engineering

Rationale: The redesignation of the Department of Engineering and Physics to the School of Engineering will 1) align UCO with metropolitan peer and near peer institutions, 2) will facilitate UCO's participation in discipline-specific endeavors, 3) will enhance recruitment efforts, and 4) will increase the visibility of our high-quality programs for fundraising and partnership efforts.

The redesignation aligns UCO with its metropolitan peer and near peer institutions. Currently, the Department of Engineering and Physics houses five undergraduate and four graduate engineering programs, along with two Science Education majors within one department. Only one metropolitan peer or near peer institutions currently houses multiple engineering programs in a single academic department. Engineering programs are typically housed within individual departments or department-level schools, which are part of a larger unit. This change will place UCO on the same playing field as our peer and near peer institutions (see list of institutions attached).

The redesignation will also facilitate participation and collaboration with discipline-specific national associations, such as the American Society for Engineering Education (ASEE). ASEE has an Engineering Deans Council, composed of engineering college deans and school directors, which meets regularly at annual ASEE meetings to exchange ideas and help resolve common issues. As a result of the redesignation, the School Director for UCO's School of Engineering can join this select group of administrators for the betterment of UCO's programs.

Additionally, the proposed redesignation will enhance recruitment efforts. Having a similar structure as our metropolitan peer and near peer institutions will allow UCO to highlight our competitive advantages, such as our high-touch educational environment, our small class sizes, and greater opportunities and support for undergraduate research. Currently, students receive recruitment materials from UCO's Department of Engineering and Physics while at the same time receiving materials from schools or colleges of engineering. A departmental designation versus a school designation may dissuade students from considering our high-quality programs. The redesignation as a School of Engineering will level the playing field and allow UCO an opportunity to communicate the strengths of our programs and the benefits of pursuing an engineering degree at UCO. We believe this will produce a positive impact on enrollment.

Finally, the redesignation will increase the visibility of our programs and strengthen our efforts in fundraising and the development of partnerships. A recent example with a corporate partner underscores the importance of elevating the unit into a school. While our strong alumni base and advisory board members' advocacy secured the partnership, the corporate partner was reconsidering working with UCO and was considering working with an institution with a school/college of engineering. The perception of UCO as a minor player in the state's engineering initiatives is hurting our programs' ability to draw in the resources needed for growth. A redesignation of the unit to a School of Engineering will heighten the visibility of our programs and contributions to the state and the discipline. UCO engineering faculty are active in research, creative, and scholarly activities, which is intentionally focused on promoting undergraduate and graduate student research. Since September 2018, there have been 10 patents granted by the United States Patent and Trademark Office to UCO with named faculty and student inventors/coinventors affiliated with the Department of Engineering & Physics. Similarly, there have been 4 international patents (1 Canada; 1 Germany, France, and United Kingdom; and 2 China) that have been issued to UCO with named faculty and student inventors/co-inventors that are affiliated with the Department of Engineering & Physics since April 2019. These accomplishments speak to the value of the quality of our programs and faculty as well as the student experience. Thus, the redesignation signals corporate partners and other stakeholders in the state the strength of our programs, faculty, and graduates.

<u>Faculty Support</u>: The proposal was unanimous supported by the faculty of the Department of Engineering and Physics and was supported by the Dean of the College of Mathematics and Science. Feedback from colleagues within the college and campus-wide strongly supports the redesignation to ensure the strengthening and growth of the unit.

<u>Resources</u>: The change in department name does not require additional funding or resources beyond those already allocated by the college and University. There will be no need for additional resources to support the name change. The only related expenses will be those associated with reprinting of materials such as stationery, business cards, etc.

Please place Southwestern Oklahoma State University on the Facilities Stewardship Committee agenda for the June 16, 2022, Board of Regents of the Regional University System of Oklahoma meeting regarding the following items:

SWOSU requests approval to transfer all land and buildings located at the Sayre Campus, Sayre, Oklahoma, to the Sayre Public School (SPS).

In 1993, the Board of Regents for Oklahoma Colleges for Southwestern Oklahoma State University purchased this property from Sayre Independent School District for \$630,000. Since that time, the campus has been used as an additional location for SWOSU to provide instruction for students to earn Associates degrees. At the time of purchase the following land and buildings were acquired:

Alexander Building	14,046 st	
Capps Building	1,291 sf	(demolished June, 2020)
Conner Building	6,850 sf	
Mackey Hall	18,720 sf	
Gymnasium	15,368 sf	
Land	8.65 ac	

In 1994 a student union building was constructed containing 5,000 sf for a total cost of \$328,918.

Enrollment at the Sayre location has steadily declined due to the growth of online classes and particularly with the onset of zoom technology during the pandemic. Spring, 2022, yielded 21 FTE students. It is no longer financially viable to continue full operations at the Sayre campus.

SWOSU requests permission to:

- cease operations and deed the property back to Sayre Public School. The SPS Superintendent has verbally agreed.
- lease a portion of the Alexander building from SPS on a year-by-year basis.
- perform asbestos abatement on the buildings at a cost of \$58,000; this cost will be split with SPS.
- demolish the Mackey Building; cost estimate not yet received. This cost will be split with SPS.
